

Destination Event Terms and Conditions

RESERVATIONS: To provide the best discounted rates, ALL RESERVATION ARE NON-REFUNDABLE. We offer Travel Guard Insurance directly to protect your trip from trip cancellation and interruptions. Non-refundable payments in full are due no less than 60 days prior to travel. Payments not made in full at least 60 days prior to travel are subject to cancellation and payments made will be forfeited. A deposit will be presented and must be paid at time of booking. Reservations made within 100 days of event required payment in full at time of booking. All prices are subject to change until deposit is received. By paying the deposit you acknowledge that you have read and agree to the Terms and Conditions presented here.

DOCUMENTS: Written confirmation will be sent via email after deposit has been received. All related Destination Event documents such as tickets, passes, ground transportation will be issued at least one day to one week before your departure. Tickets to events will only be sold as part of hotel or hotel + air packages. Tickets to events will be sold in pairs (ie, per person/double), as odd numbers and groups cannot be guaranteed.

RESPONSIBILITY: You represent and warrant that (a) you are of sufficient age to use our services and website and can create binding legal obligations in connection with your use. Black Diamond Summit Tours is not responsible for any delays in transportation that may cause package clients to miss and events of the package. The suppliers that provide travel and features are independent contractors and principles, agents, employees, master, servants, representatives, partners or ventures of Black Diamond Summit Tours. Black Diamond Summit Tours assume no responsibility nor any liability in connection with the service of any of these suppliers including train, vessel, carriage, aircraft or other conveyance or hotel which is used, either wholly or in part in the performance of its duty to the passengers, neither will they be responsible for any act, error or omission or for any injury, loss, accident, delay, irregularity or expense arising from strikes, war, weather, quarantines, sickness, pandemic, government restrictions or regulations, Act of God, or any other reason whatsoever. Weather conditions may affect your travel to and from an event. If you are unable to arrive in a timely fashion due to weather - there are no refunds allowed. If an event is cancelled in its entirety due to weather, any/all refunds will be in accordance with the rules and regulations of the venue and/or team affiliated. In case any event is postponed due to inclement weather or other factors beyond our control, no refunds will be made and participants will be responsible for alternate accommodations and/or travel arrangements. Additional expenses or fare revisions, if any, shall be borne by the passengers, conversely, refund will be made to the passengers if any saving is

effected thereby. Black Diamond Summit Tours reserves the right to terminate the event participation of any person who is abusive of others or whose behavior disrupts the operation of the package. Any condition or disability requiring special attention must be reported to Black Diamond Summit Tours at time of booking and we will advise hotels and airlines of any special requests, but they cannot be guaranteed. Persons needing such assistance must be accompanied by an able companion who will assist them provided they pay the package costs. Credit card payments: Program participant agrees not to charge back any bank charges against his/her credit card for products and services rendered by Black Diamond Summit Tours and received by program participant. Any disputes and discrepancies must be made in writing within 30 days of conclusion of event. Further, any claims that may arise must be filed in Denver County, Colorado exclusively. The right is reserved to substitute hotels, and alter the itinerary or reverse the places to be visited. The right is reserved to cancel the package any time prior to departure. If any package must be withdrawn prior to the passengers joining the package, Black Diamond Summit Tours liability is limited to a refund of monies received by Black Diamond Summit Tours in the same form of payment as received.
